How Can I Submit an Assessment to the Court prior to my hearing?

There are two possible ways you can submit an assessment to the court:

1. You can either bring the assessment to court by hand, OR
2. You or your treatment provider can submit the assessment to the Springville Court before the hearing date by emailing it to justicecourt@springville.org

The judge reviews the assessment BEFORE your hearing, so please provide it at least 24 hours before the hearing.

NOTE: If your treatment provider tells you they will submit the assessment directly to the court, **you still have the responsibility to contact the court and verify that it has been received.** You may contact the court or submit an assessment at any time during regular business hours, Monday through Friday 8:00am-5:00pm using the information below:
