

RESOLUTION #2013-26

**A RESOLUTION FINDING AND PROMULGATING THE RESULTS OF THE
GENERAL MUNICIPAL ELECTION FOR MAYOR AND CITY COUNCIL POSITIONS
HELD IN SPRINGVILLE CITY, UTAH ON NOVEMBER 5, 2013**

WHEREAS, an election was held on November 5, 2013 to fill the position of Mayor and positions on the City Council with terms that expire on the first Monday of January, 2014; and

WHEREAS, the election was duly and regularly held, and the election results have been officially canvassed by this City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Springville City, Utah, acting as the Board of Canvassers, as follows:

Section 1. It is hereby officially found, determined and declared that 1,776 votes were cast for Wilford W. Clyde in the race for Mayor; and that, 946 votes were cast in favor of Craig Conover; 1,108 votes were cast in favor of Chris Sorensen; 908 votes were cast in favor of Joyce Nolte; and 906 votes were cast in favor of Karen Ellingson in the race for City Council.

Section 2. According to the above results, it is hereby declared that Wilford W. Clyde has been elected by the residents of Springville to the position of Mayor for a four-year term beginning January 2014 and ending on the first Monday of January 2018. It is also hereby declared that Chris Sorensen and Craig Conover have been elected by the residents of Springville to the position of City Council members for four-year terms beginning January 2014 and ending on the first Monday of January, 2018.

Section 3. The election results of the votes cast (a true and correct copy of such results have been provided to the City Council by the City Recorder and attached hereto) are hereby certified by the City Council as the official election results from each and every polling place established for the election.

Section 4. This Resolution shall be effective immediately upon its adoption.


